Executive Summary: It has been a pleasure to work with Coronado National Forest, National Forest Foundation and Borderland Restoration Network. BRN submitted and was approved for a NFF grant which will continue this project into the future. The reason for this transfer of leadership was the QF national organization not allowing the chapter to manage the project. SAQF will provide the matching funds to BRN.

Financial report form and pictures are attached. Status of goals and metrics are provided below. We spent all provided funds.

Our project started on time and completed on schedule in terms of spending and work completion. We had an internal goal to finish a little earlier than the timeline provided in our grant agreement. No modifications were required. Borderlands Restoration Network's (BRN) program manager left for other employment and an encounter between USFS law enforcement and BRN personnel on the work site slowed progress in Feb but we were able to make up the time. BRN has hired a new program manager who completed the project.

There were COVID impacts on contract work but it has been relatively minor. It has more significantly slowed our volunteer hours and has resulting in small transportation cost increase. The reduced volunteer hours impacted our in kind donation.

Matching funds included a grant from AZ Sportsman for Wildlife Conservation as well as donations from Fisher Foundation and chapter members.

Narrative Summary: The work on this project was highlighted with the chapter winning two significant conservation awards. The AZ Game and Fish Commission singled out the chapter as the Conservation Organization of the Year for 2020. Quail Forever also designation the chapter as the QF Habitat Chapter of the Year. Both awards included language on the grasslands project and were widely distributed.

Borderland Restoration Network has provided monthly status reports that were forwarded to Coronado National Forest, AZSFWC, Fisher Foundation, National Forest Foundation, QF National and AZ G&F. Below is an example of information provided to members and other interested parties through our monthly newsletters and website.

Habitat:

We continue to build numerous rock structures on our Coronado National Forest Grasslands Project. National Forest Foundation, Fisher Foundation and AZSFWC are some of the significant donors supporting this work. Our loose rock dams help by slowing runoff to keep water in the soil longer and retaining soil to grow habitat. To date, we have completed over 600

structures this season alone. The work completed the last few years looks great after our rainfall.

Borderlands Restoration staff led two groups of high school and college students in building erosion control structures in the project area. Both groups were part of the Borderlands Earth Care Youth (BECY) summer program; one group was based in Patagonia and the other in Douglas. The Douglas crew included 9 interns and 2 facilitators, and the Patagonia crew included 8 interns and 2 facilitators. The crews worked for 4 days on the project and completed 74 structures.

Borderlands was awarded a matching funds grant from the National Forest Foundation to continue our work along the border. We will support with funding.

Status on goals provided in blue:

Goal 1: BRN staff will install erosion control structures to mitigate erosive forces degrading the Border 2 and Border 3 regions of the Coronado National Forest. Simultaneously, the erosion control structures will build the soil, increase surface water availability, and support vegetation. Total number of structures is 709. This includes 469 one rock dams, 4 media lunas, 94 hybrid log-rock structures, 27 rock rundowns, 26 zuni bowls, and 89 rebuilds. Lat/long for each structure is attached.

Goal 2: Wildlife will access the temporarily detained surface water at the erosion control structures. Some species, such as the Montezuma Quail (which can only be found in abundance in southern Arizona), have been identified as species of highest concern due to climate change. A lack of water availability is a direct threat to these species. These structures are primarily intended to preserve water from monsoon rain but will also do the same for our winter rains. The attached photos show how the structures retain monsoon rainfall

Goal 3: Seed balls incorporated with the erosion control structures will grow into healthy vegetation, further stabilizing the soil and improving water infiltration. The seed balls will be comprised of a carefully selected mixture of locally sourced, native vegetation intended to support wildlife populations. All planned seeds were collected on the forest, cleaned and made into seed balls with a total of 18 pounds collected. The seed balls were placed in the summer just prior to monsoon period with many sprouting during monsoon. Species include: Lycurus setosus, Bouteloua hirsuta, Bothriochloa barbinodis, Bouteloua curtipendula, Cyperus esculentus, Elionurus barbiculmis, Schizachyrium sanguineum, Elionurus barbiculmis, Piptochaetium fimbriatum, Eragrostis intermedia, Muhlenbergia emersleyi, Bouteloua chondrosioides, and Hopia obtusa.

Goal 4: Wildlife will utilize the vegetation for habitat and forage. Rather than seeing a decline in wildlife populations due to environmental stressors, wildlife populations will persevere. AZGFD will complete annual surveys to determine population impact.

Goal 5: Hunters, birders, and other outdoor enthusiasts will continue visiting and enjoying these restored lands, hoping to spot wildlife. Time will tell.

Goal 6: BRN will engage local high school youth to learn about conservation, CNF and ecological restoration. The Borderlands Restoration staff led two groups of high school and college students in building erosion control structures in the project area. Both groups were part of the Borderlands Earth Care Youth (BECY) summer program; one group was based in Patagonia and the other in Douglas. The Douglas crew included 9 interns and 2 facilitators, and the Patagonia crew included 8 interns and 2 facilitators. The crews worked for 4 days on the project and completed 74 structures.

Goal 7: BRN and SAQF staff will train volunteers to build erosion control structures and teach them best practices for planting seed balls in and around erosion control structures. We trained and used 12 volunteers that recorded 203 hours over the period. The numbers here were negatively impacted by COVID but we still consider it a success

Goal 8: Volunteers will work with BRN and SAQF staff to install erosion control structures and seed balls at the site. Volunteers will aid in returning the site to a trajectory of recovery, spending time outdoors and gaining a firmer sense of stewardship for the region. Completed.

Goal 9: Integrate with the overall Coronado National Forest Grassland Restoration Project. Forest thinning has continued during the same period, CNF staff has been kept informed of our progress and planning.

Metrics planned vs completed:

- -Install 600+ water-harvesting erosion control structures 709 complete
- -Collect and distribute 16+ lbs of native seed in seed balls 18 lbs distributed
- -Restore 300+ acres of currently degraded wildlife habitat 690 acres
- -Engage at least 12 high school-aged youth in restoration projects 17 high school and college age youth trained
- -Engage at least 30 volunteers, including 10 that have not participated before 12 volunteers (down due to COVID impact)
- -Supported jobs for four restoration practitioners through BRN supported 4 jobs
