**Summarize Project Accomplishments:** Maintain grassland through herbicide spot treatment of new growth mesquite on 3 contiguous pastures totaling 1,571 acres on the Vera Earl Ranch that were grubbed in 2012 and 2014.

Treatment effectively removed mesquite regeneration by targeting mesquite 6 foot and under, resulting in continued grassland restoration and Pronghorn habitat Preservation. Attach narrative if more space is needed.
