Summarize Project Accomplishments:

Last June, 12 lucky kids were selected to attend the Wild Sheep Foundation / Boone and Crockett Outdoor Adventure Camp held at Theodore Roosevelt Memorial Ranch in Montana. They were selected from a group of talented youth that had submitted essays on "Who benefits from a waterhole project and why?"

Once there, they were immersed in outdoor life, including activities like archery, trap shooting, kayaking, pack rafting, fly fishing and hiking. Several conservation and outdoor experts provided seminars and workshops on topics including invasive plants and weed abatement, bear spray training, fly tying and health risks from the interaction of wild and domestic sheep populations throughout the west.

Highlights of the trip included hiking and kayaking through the picturesque Montana wilderness with numerous sightings of beavers, elk, deer, eagles and even a grizzly bear. A special thank you to two very dedicated ADBSS Board members, Gill Mills and Sam Gorton, who chaperoned these kids on this once in a lifetime trip.

The cost to attend this camp was generously underwritten by funding from The Wild Sheep Foundation, the Boone & Crockett Club, the Az. Desert Bighorn Sheep Society and by a grant issued through the wildlife license plate program administered by the Az. Sportsmen for Wildlife Conservation.
