Summarize Project Accomplishments: Blair Ranch has approximately 14 miles of old woven sheep fencing that is a barrier and an entanglement hazard for mule deer migrating from GMU 7 into GMU 9. It also contains some of the best pronghorn antelope habitat in GMU 9, but movement fragmentation is occurring due to the fencing. The Arizona Game and Fish Department Research Branch had GPS collared Pronghorn in the area and data shows some of the fence in the area is a huge factor prohibiting wildlife from moving freely throughout the area. The ranch manager of Blair Ranch was contacted and discussed the opportunity to update the woven sheep fences two miles a year until approximately 14 miles of fence is replaced with wildlife friendly barbed wire fencing. The AZSFWC grant of \$9,000 was used for the purchase of 2 miles of fencing material. The ranch preferred to install the fence on their own, providing \$6,000 of in-kind installation cost. The project material purchased was able to complete 2.25 miles of fencing, 0.25 miles above what was expected. This project will increase movement corridors for mule deer as well as pronghorn distribution in unit 9.
