



Arizona Sportsmen for Wildlife Conservation

Today is Day 50 of the Fifty-sixth Legislature's First Session. 1625 Bills, Memorials and Resolutions have been introduced. 14 bills have been passed by both chambers and submitted to Governor Hobbs, who has vetoed all of them. The stage is set for continued drama downtown.

If a bill hadn't been heard in Committee by last week, it is essentially dead, unless it becomes the product of a "striker".

HB2411 began as a water supply related bill and is now deals with grazing leases and renewable energy projects.

Here are a few of the bills we have been tracking that are "dead", at least so far:

HB2236 would have granted any enrolled member of a federally recognized Indian tribe wholly or partially in Arizona an exemption from any fees, licenses, permits, tags, stamps, or application fees prescribed by AZGFD.

SB1057, the Alpine Horse bill introduced by 2022's HSUS Legislator of the Year, would have essentially emulated on the Apache National Forest what is taking place on the Tonto National Forest with the Salt River horse herd.

SB1364 was Senator Mendez' annual effort to eliminate the Commission Appointment Recommendation Board.

Many bills continue to advance, however it's anyone's guess on their eventual outcome.

HCM2005 is a House Concurrent Memorial sponsored by Representative Griffin. If successful, it would urge the U.S. Congress to respect the historic and current use of Arizona's recreational areas by sportsmen and sportswomen, support the time-honored Arizona traditions of hunting and angling, and respect the administration of wildlife conservation through the science-based policies developed by the Arizona Game and Fish Commission.

Arizona's Livestock Loss Board (LLB) has two bills of interest that remain alive.

SB1002 would appropriate \$250,000 from the State's General Fund to the compensation fund of the LLB, for livestock depredation, not compensation for the Board, which was subsequently clarified in an amendment.

HB2644 would appropriate \$132,448 from the State's General Fund to the State's Department of Agriculture to employ a peace officer to investigate wolf depredation on livestock in Arizona. <https://www.azleg.gov/legtext/56leg/1R/bills/HB2644P.pdf>

Off highway vehicles (OHV) remain on the legislative landscape.

SB1100 changes the definition of OHV's based on weight and reduces the commensurate vehicle license tax.

SB1393 establishes the Off-Highway Vehicle Law Enforcement Safety Fund (OHVLES Fund), to be administered by the State Treasurer and distributes the money by percentage to county sheriff's offices, as well as the governing authority.

Finally, on the water front two bills are still afloat, one would require engine cutoff switches and an audible signal device, and the other would exempt anyone under 12 from wearing a personal flotation device if you are in a "rowing shell".

Gary Stinson Grant Fund. AZSFWC will review and approve all grants from the special license plate program revenues.
