# ARIZONA SPORTSMEN FOR WILDLIFE CONSERVATION SPECIAL PLATE

#### **Summary of Changes**

Removed from Section I, two plates are issued.

#### **Purpose**

Guidelines for the issuance of an Arizona Sportsmen for Wildlife Conservation Special Plate formally known as the Wildlife Conservation Special Plate.

#### **Authority**

Laws 2018, Chapter 279, S.B. 1524, effective August 3, 2018. Administrative Revision November 2014, A.R.S. §§ 28-2151, 28-2402, 28-2404, 28-2409, 28-6991 and 35-146

#### **Policy**

- A. The Division is authorized to issue an Arizona Sportsmen for Wildlife Conservation Special Plate. The Arizona Sportsmen for Wildlife Conservation Special Plate is available through the internet at AZMVDNOW.GOV and by The Division's Special Plate Unit.
- B. There are no customer qualifiers for the Arizona Sportsmen for Wildlife Conservation special plate, however the plate cannot be issued to the following:
  - 1. Motor vehicles with a declared gross vehicle weight (GVW) over 26,000 lbs.
  - 2. Any vehicle that is issued a smaller size license plate.
- C. The Arizona Sportsmen for Wildlife Conservation special plate may be issued to all categories of Arizona trailers and are available through the internet at AZMVDNOW.GOV.
- D. The Arizona Sportsmen for Wildlife Conservation plate is available with the International Symbol of Access ( ), see Policy 12.2.11 Disability License Plate/Placard and is issued by the Division's Special Plate Unit.
- E. The Arizona Sportsmen for Wildlife Conservation plate may be personalized, see Policy 12.2.32 Personalized License Plate.
  - 1. Special Plate Application, form #96-0143.
  - 2. A personalization fee of \$25 is required in addition to the special plate fee.
  - 3. The maximum amount of characters allowed is six.

- F. The owner may transfer the Arizona Sportsmen for Wildlife Conservation plate to another vehicle that he or she owns, provided the vehicle meets the criteria outlined in Section B of this policy. The owner must pay a special plate transfer fee.
- G. Pursuant to A.R.S. §§ 28-2151 and 28-2402, the following additional fees are required:
  - 1. An initial application fee of \$25.
  - 2. An annual renewal fee of \$25.
  - 3. A special plate transfer fee of \$12.
  - 4. A postage and handling fee, see Postage and Handling Fees chart.
- H. For the Arizona Sportsmen for Wildlife Conservation plate key and plate type, see the Plate Key/Plate Type chart.
- I. The plate format for the standard, personalized, disability plates are as follows:
  - 1. The plate format for the standard issue plate will be seven characters and include the letter "W" or letters "CW" (Example: W#####, ####W# #CW####, ####CW#).
  - 2. The plate format for the personalized plate will be a maximum of six characters.
  - 3. The plate format for the disability plate will be four characters and include the letters "**P**" and "**W**" or letter "**CW**" (Example: ###W, ##CW, #CW#).
- J. Pursuant to A.R.S. § 28-2404, from the monies received for the Arizona Sportsmen for Wildlife Conservation special plate, The Director Shall Remit \$17 of the fee as a donation To Fund Wildlife Habitat Projects, Outdoor Recreational And Educational Opportunities.
- K. Customer Service Representatives shall follow the established procedures for ordering and issuing personalized Arizona Sportsmen for Wildlife Conservation Plate special plates using the MVRSP, MVRPP and MVAPP transactions.
- L. Customers may request any special plate by mailing their application along with the check or money order for the appropriate fee (including postage) to the address on the application.
