Summarize Project Accomplishments: Red House Trick Tank is a Forest Service wildlife drinker that is located in Unit 7 East on the Coconino National Forest. This catchment had a new apron constructed to efficiently catch rain water and store in the 3,000 gallon storage tank. The new apron structure was built to AZGFD standards, and materials will be purchased locally. All old material was hauled off and disposed of responsibly. This portion of 7E has a healthy heard of mule deer, elk, and pronghorn and in the area surrounding this water catchment, a large numbers of these species spend their winters. This project accomplished the target goal of increasing the efficiency of this catchment so that it can provide a reliable source of water in a critical area of Unit 7E. The funding requested for this project was used to materials to rebuild the current apron. The work will be led by Tom Mackin, a local volunteer, and an additional 16 volunteers from the Northern Arizona Chapter of the Mule Deer Foundation and Coconino Sportsmen came out to help reconstruct the apron. The surrounding barbed wire fence was also modified to include a smooth bottom wire 18" off the ground for easy access for wildlife to the drinker. It also included jump segments (PVC pipe) to prevent entanglement and damage from the barbed wire.
