AZSFWC – SRP Partnership Overview

- Sept. 2021 AZSFWC and Arizona Deer Association invested in the Hardscrabble Project
 - Nov. 2021 Hardscrabble began operations
 - March 2022 Hardscrabble concluded operations
- Project Accomplishments:
 - 1,166 acres completed
 - Decreased shrub cover by 65.8%
 - Decreased tree cover by 92.1%
- Total Project Costs: \$582,801.80
 - USFS: \$150k AGFD: \$50k
 - AZSFWC/ ADA: \$30k Pine/ Strawberry Fuels \$30K
 - APS \$10K SRP \$327K




